The Department often has applicants, who are under the age of 21 years old; however, the truck driver job description currently requires employees to be 21 years of age or older. Per state law, a Commercial Drivers' License (CDL) may be obtained at the age of 18; therefore, the Department is requesting that the job description be amended to lower the age to 18. Legal has found no basis for the 21-age requirement, nor did the County's consultant Waggoner, Irwin, and Scheele. This issue was heard by PAC, who did not object to the amendment. It was voted to be passed along to the full Council for adjustment of the age requirement from 21 to 18.
