Sealed bids for the items listed below will be received at the Monroe County Legal Department, Monroe County Courthouse, 100 W. The bids will be opened and read aloud one hour later at 11:00 AM E.S.T. in a Zoom meeting by representatives of the Monroe County Highway Department. The building is open to the public Monday thru Friday, 8:00 am to 4:00 pm. Any bid received after this time will be returned unopened. Bids transmitted by facsimile machine or e-mail will not be accepted.

Bidder shall supply material at bidder's asphalt plant and placed in Monroe County trucks.

It shall be the responsibility of the bidder to provide itemized monthly billings. Bid prices shall hold for one year from the date of the award by the Board of Commissioners of Monroe County.

The term covered by this bid shall be one year from the date of the award by the Board of Commissioners of Monroe County. The contract to supply materials and supplies may be renewed beyond the expiration date to another term, not to exceed two additional one-year terms, by agreement of both the County and the Bidder.

The Owner reserves the right to accept or reject any Bid, *or portion of the Bid*, and to waive any irregularities in the bidding. All bids may be held for a period not to exceed 60 days, or as otherwise stated in the Contract Documents before awarding the contract.

If the bid is for sand, gravel, asphalt paving materials, or crushed stone the County may award contracts to more than one (1) responsible and responsive bidder based on geographic location, availability and customer service.

All out-of-state corporations must have a certificate of authority to do business in the State. Application forms may be obtained by contacting the Secretary of State, State of Indiana, Statehouse, Indianapolis, Indiana 46204.

All bidders shall comply with Chapter 275 of the Monroe County Code, the Responsible Bidder Ordinance.
