- II. Continued discussion of CJRC Members’ Vision

Do you agree that we must focus first and mainly on the broad categories: Facility and Intercept 0?

If not, why not?

If so, for the Facility:

How do you want to develop CJRC’s vision for a facility? Must you gather the community and other stakeholders’ vision for a facility as part of developing your vision OR is your process separate?

When does facility planning/visioning begin - before or after a location is identified and other land is purchased?

Is this planning/visioning led by CJRC OR is another person/group in charge of leading the process and CJRC is, simply, involved?

For Intercept 0:

We must develop a list of strategic partners and focus our resources – who do you want on that list of partners and what specific areas do you want to focus?

Intercepts 1-6 (Eve Hill added a sixth, for us. See page 37 of her report):

Do you agree and recognize that you have a role related to Intercepts 1-6, which are directly under the JRAC (which includes the Courts, Sheriff, Prosecutor, and Public Defender), because you approve agreements and pay for facilities and programs related to those Intercepts?

If not, why do you not see that you have a role, even if it is an indirect role?

If so, do you want Intercepts 1-6 to be included in your strategic plan and in your action steps?

How do you want to include others in the development of your strategic plan and action steps? (i.e., do you want others invited to your meetings, do you want me to talk with them and report back? What process makes you comfortable?)
