### Open Enrollment

Open enrollment dates are October 25 through November 1, 2022. The benefits platform Steele Benefits will store your elections and your waivers: <http://guardian.benselect.com/>. **Your username is your SSN, your password is the last 4 of your SSN and the last 2 of your birth year.** Benefit assistance is available through Employee Services or you may call Steele Benefits at 463.999.8151 Monday – Friday 8:30a to 4:30p.

### Choose Carefully

Due to IRS regulations, you cannot change your elections until the next annual Open Enrollment period, unless you have a Qualifying Event during the year. The following are examples of the most common Qualifying Events:

- ▶ Marriage or divorce
- ▶ Birth or adoption of a child
- ▶ Child reaching age 26
- ▶ Death of a spouse, Registered Domestic Partner (RDP), or child
- ▶ Change in child custody
- ▶ Change in coverage election made by your spouse/RDP during his/her employers Open Enrollment period
- ▶ You lose coverage under your spouse's/RDP's plan

  - All employees on Monroe County Health Plan 3 receive a Monroe County paid **\$5,000** Critical Illness policy
- Premiums are calculated during enrollment

- Hospital Indemnity Plan
  - Receive a cash benefit if you are admitted to the hospital
