- 1. Approval of the March 18, 2022, meeting minutes
 - a. Moved by Jean
 - b. Seconded by Penny
 - c. Approved
- 2. Announcements from commission members (12:03-12:10)
 - a. Penny: City and county have more money from opioid settlement. Are there recommendations on how to use?
 - i. Will entertain that in next meeting
 - ii. Nick: IRA is looking for a building should we wait to discuss in next meeting
 - iii. Erika: need to figure out how it can be allocated?
 - iv. Penny: certain amounts must go towards treatment. Will continue to roll in. Penny will talk with Nick about IRA. Harm reduction is important
 - v. Nick: has a presentation for funding and letter of approval. Has reached out to Health Dept. Mayor said he can't help for the building and suggested to reach out to county. Nick is looking into more services if IRA has a building.
 - vi. Erika: we will investigate the restrictions and what we can do.
 - vii. Nick: we can add a nurse's curriculum, recovery options, will help community.
- 3. Joani Stalcup: 2021 Drug Overdose Deaths (12:10-12:25)
 - a. More drug overdose deaths than ever in 2021, 54. Fentanyl, mostly a mix with meth. Doesn't include suicide DO deaths

- b. 2022, 15-18 DO deaths, mostly fentanyl, emerging novel substances (heroine type, in 2-3 cases, synthetic from 40-50 yrs ago in Sweden and is resurfacing and rare finding). Can email the name out after the meeting.
- c. No heroine, only fentanyl, so we need to educate people. Families have the two drugs confused.
- d. Penny: where are novel drugs coming from?
 - i. Not anywhere local, brought in. Detectives are aware and Joani contacts detectives, not locally manufactured.
- e. Nick: doesn't see heroine either. Does the drug contribute to death (meth mixture)?
- f. Joani: there is more mixture of fentanyl and meth. The high is different, and many people know they exist.
- g. Nick: trying to have fentanyl test service. People have thrown away foreign mixtures too. ISO, seen a lot lately.
- h. Joani: one is ISO.
- i. Nick: finding more often.
- j. Joani: ISO is a type of benzo. The scary part is Narcan cannot reverse OD
- k. Steve: most substances are not controlled substances yet. Not able to regulate
- I. Joani: yes, the Sweden drug is resurfacing
- m. Erika: hard to keep up with testing of drugs and keep up with analog substances. In those cases, we can only charge for dealing.
- n. Jean: age disparities or racial groups overrepresentations in death?
 - i. Joani: ages 20-50s. Big age range.
 - ii. Primarily white folks.
- o. Penny: Sam Quinones (sp): will touch on the mixture issues (ski ball). Would like to have Joani in the conversation with Sam.
- p. Joani: in toxicology report is up to 400 now
- q. Beverly: any place where OD deaths are publicly located?
 - i. Joani: in coroner office, a log is kept. Only released upon request, due to death sensitivity. Was published before with City of Bloomington.
- r. Kathy: 60% is fentanyl and 40% meth for last year.
 - i. Joani: yes, majority are fentanyl.
- 4. Vacancies on the commission (12:25-12:30)
 - a. Any pending applications or recent appointments? 2 openings as of March 18, 2022
 - i. Erika: not counting Carol, 2 openings
 - ii. Any other recruitment?
 - iii. Nick: Pamela Brown-Sparks (sp), not sure if she applied yet.

 - b. ELO emailed application to Whitney Meeks on March 18, 2022, and she applied
