 - b. Waiting to see where things stand with the grant money.

5. IRACS & RCO

- a. What are their stipulations? Jayme Whitaker has met with sheriff and his staff. Still some things to discuss regarding the needs of IRACS programming and Sheriff. As soon as that is ironed out, can work on next steps which means we need a recovery community organization.
- b. Any timeline? A: not yet but Penny will let us know
- c. Nick has put in preliminary application for the RCO. Note that Kelly Hans is doing IRACS right now, so it would be helpful to see what her program is doing right now during the Lunch and Learn

- 7. CHIP
 - a. Group worked to align the systems map and include key points of the SIM model. Looking at the map, it is read from left to right and can be read as a persons experience of risk/protective factors, their interaction with substance, development of substance use disorder or interactions with other negative structures within the community and then looking at other key points, helpers, enablers, barriers that folks experience on their journey towards recovery.
 - b. Hoping to enhance the map during next week's meeting
 - c. Kathy/Melanie met with Kathleen Sobiech who is a certified SIM mapping facilitator
 - i. Potential to engage with SIM mapping as a followup to the mapping project.
 - ii. 1.5 days for facilitated SIM mapping

- iv. Would likely have to wait till 2024 to facilitate training
- v. Would end up with report and could enhance visual tool of Purdue Extension/MCHD/CHIP group
- vi. Could extend part of the Summit to engage further
- d. Did Public Defenders office do a SIM mapping project in Indy earlier in the year?
 - i. To Do: Karen to ask if there's a pre-existing map from her office
- e. Would like to see if there is a way to combine GIS storymap, CHIP map, SIM mapping
- f. To Do: If you have feedback on the maps, let Melanie know
- g. To Do: print the maps when in a more finalized state to better study the system.
