12:10 Grand Challenge Update – Mary Lynn Davis & John Simmons

Proposal to look at relationships between ACEs and social determinants of health and the risk for SUD

Looking at national data sets and national survey of child health Relationships between answers to ACE questions and social determinants questions

Submitted 2 grants for this commission – Firestarter Grant (\$5,000) a specific and concrete action plan; and Trailblazer Grant (\$25,000) map database of children being cared for by grandparents, aunts/uncles, etc.

We were not able to meet with Hoosier Action this month; however, we still plan to partner with them to track bills that are relevant to this group Hoping Brad Swain can talk with Steve Luce to gain support for Tell an Officer Bill IRA applied for 2 grants that could be put toward Legislative Committee

12:22 Overdose First Response Update – Beth Sarchet & Chris Abert

Showed "The Caring Community" at MCPL – educated patrons about safe injection sites 25-50 people attended, great discussion at the end

Discussed organizing more events similar to this one

*We need more commission members to attend these events

Amethyst is thinking about giving out Narcan

Committee is going to reach out to other treatment sites and encourage them to do the same

Committee expanded to looking at Basic Needs in addition to First Response

12:32 For Profit/Non-Profit - Chris Abert

Met with the county, city, and stakeholders to end the yearlong moratorium on new treatment sites

12:34 Family and Stigma – Kathy Hewett

Trying to figure out how to get youth involved

Unsure of what is being offered for volunteers (meals, free ticket, etc.) Reach out to National Honor Society members (they need to fulfill a volunteer requirement to maintain group membership) Original plan was to start recruiting volunteers by June 1st Reach out to churches to get support

12:36 Cook Meeting - Chris Abert, Amanda Barge, Mark DeLong

Cook didn't quite understand our commission's agenda, now they are on the same page Discussion about how many detox beds needed (~40)

Cook is trying to draw in Central Indiana Corporate Sponsorship
