Work on creating a database to identify the population and what services are needed

Give caregivers the resources they need

Continue to do outreach to any groups willing to engage with us

Hire a group facilitator to lead these conversations?

1:22 Pathways Presentation

Averaged 100 calls per month (since January 8th)

Patients seeking inpatient care, outpatient care, support groups, emergencies

Mixture of clients with and without insurance

Able to place about 30 per month in inpatient, about 20 a month on waitlists (Stepping Stones, Recovery Matters) because they don't have insurance

Amethyst and Centerstone takes everyone – easier to get people connected

Safety Planning

Shelters, access to food, needle exchange programs

Formed partnerships

Crawford House and Shalom (3 hours a week)

Indiana Recovery Alliance

Challenges:

Clients without phones/transportation

Clients without Anthem (if they want inpatient)

Pregnant women
