(Jackie Nester) So this is a National Register Nomination for the Dr. Robert L and Ellen Milisen House located at 4180 N Old State Road 37. It's a 1.75a parcel in Bloomington Township. Many of you have probably noticed it before as you're driving up N Old State Road 37 kind of at the top of the hill. So part of this nomination includes two contributing buildings. We have the actual home which is a three bay American Foursquare home as well as a two bay garage. The home was built around 1931, so it's eligible for a National Registered Nomination. So what we're looking for today is approval by the Commissioners to send this to the State for their official nomination to the National Register. It also includes two contributing objects, a drive way gate posts and a picnic table and then as well as a contributing structure which is a retaining wall. I'll just kind of go through some photos here. Top left you see the home and the garage. The home was originally built for a professional wrestler, Billy Thom, in 1931 and then later Dr. Robert and Ellen Milisen moved into the home. Dr. Robert Milisen is known for his starting of the IU Speech and Hearing School. Recently in 1998 they renamed the school after him, so he is a notable figure which is one of the contributing factors why this nomination is moving forward. So just some photos of the inside of the home dining room area and then the upstairs room over the sun room addition and the bedroom there as well. And then we also have some other contributing structures and objects as I mentioned so the gate posts, picnic table as well as the retaining wall. All in great shape. The site over all is really intact. So it does qualify under several criteria's as I mentioned so it's associated with people that are significant in our past, embody characteristic's type, period, or method of construction and also its less than 50 years old or achieving significance within in the past 50 years. At the July 15th Preservation Board of Monroe County approved this designation for the Commissioners review. And just some photos here this is Robert L Milisen Speech Language and Hearing Clinic was recently named after him, on the right you can see his name above the school. So this is kind of a great thing as IU reaches their bicentennial hoping to get some recognition for this and it's just located right inside the County.

(Githens) I think it's great that it also has the limestone connection with Monroe County.

(Jones) Very nice.

(Thomas) These are easy decisions for us to make. I just applaud the homeowner for being willing to take this step and to ensure the future for this beautiful home for our community as a whole, even though it is their home they've really given it to the Nation in a way. It's really a wonderful thing.

(Nester) The current owners Dr. James Deveraux and his wife Cathy, they are interested in having National Register Nomination. Anyone that's interested in this designation as well is welcome to come to our HP board meetings, 3rd Monday of the month, located at the North Showers Building or they can contact me with any questions.
