REGULATORY AGENCY: The Monroe County Health Department (MCHD) handles complaints involving animals such as dogs, cats, bats, rats, squirrels, chipmunks and raccoons. We also work closely with the City of Bloomington Animal Care and Control Office, the Monroe County Animal Management Office and other state and local health departments.

FAQs:

- **What should be done if someone has been bitten by an animal?**
 - The incident should be reported to the City of Bloomington Animal Care and Control Office (see link #2 and local resources) as soon as possible.
 - Wounds should be washed and flushed immediately with soap and water for 10-15 minutes.
 - The wound should be cleaned thoroughly with 70% alcohol/ethanol or povidone-iodine, if available.
 - The victim should visit a healthcare facility as soon as possible for further treatment.

REGULATORY AGENCY: The Indiana Department of Environmental Management's (IDEM) Office of Air Quality regulates the removal of asbestos containing materials (ACMs) from commercial, industrial and institutional structures. Residential structures and apartment buildings with four or fewer units are exempt from both federal and state regulations. IDEM is responsible for the licensing of asbestos removal professionals. Waste hauling and disposal requirements are applicable in most cases.

FAQs:

- **What is asbestos?**
 - Asbestos is a group of minerals consisting of thin, microscopic fibers once widely used in construction due to its heat, fire, and chemical resistant properties. When products containing asbestos are disturbed, the tiny fibers can be released into the air. When breathed in they can become trapped in the lungs and stay there for many years causing serious health problems.
- **Who can test for asbestos?**
 - The Indiana State Department of Health (ISDH) Chemistry Laboratories (*see link #2*) can test samples for asbestos analysis. Samples will only be accepted from the Indiana State Department of Health Indoor and Radiologic Health Division or from a County Health Department. MCHD can accept samples from the public to submit to ISDH for testing, but there are requirements that must be met. Solid material such as building materials, insulation, pipe wrap, ceiling tile, floor tile, etc. may be submitted.

REGULATORY AGENCY: A regulatory agency does not currently exist.

CODES AND REGULATIONS: There are currently no codes or regulations concerning bed bugs at the federal or Indiana state level.

FAQs:

- **What do bed bugs look like?**
 - Adults are ¼ inch long, reddish-brown and oval-shaped.
- **Where can bed bugs be found?**
 - Bed bugs are active at night and hide during the day in small cracks and crevices such as folds in mattresses, box springs and behind head boards.
- **What diseases do bed bugs transmit?**
 - They are not known to transmit diseases, but their bites may cause swelling, inflammation, itching and secondary skin infections. Frequent feeding can result in sleeplessness and emotional distress.
- **How do I get rid of bed bugs?**
 - Control of bed bug infestation is very difficult. It is best left to professional pest control companies that have the approved insecticides and the application equipment to effectively treat the places where bed bugs may hide.

REGULATORY AGENCY: The Monroe County Health Department (MCHD) is responsible for filing, preserving, maintaining and issuing accurate birth records for persons born in Monroe County, Indiana from 1882 to present. The Indiana State Department of Health (ISDH) oversees these operations (see [link #1](#)).

FAQs:

- **How do I apply for a birth certificate?**
 - You can apply in person, through the mail or through Vital Chek (see [link #4](#)). If applying through the mail, you will need to fill out an application form (see [link #5](#)) and mail it in with a photocopy of your driver's license or state issued photo ID, a check or money order for the correct amount and a self-addressed stamped return envelope. If applying in person, you will be required to fill out an application form in our office, show ID and pay the fee at that time. Birth certificates are issued as a set that includes a wallet size. All birth certificates are certified with an embossed seal.
- **How do I register a home birth?**
 - Please call the local health department in the county in which the birth occurred. If the birth occurred in Monroe County, call the Vital Records staff at (812) 349-2542 to schedule an appointment and get information regarding which documents will be required for registering the birth.
- **How do I apply for genealogy certificates?**
 - Follow the same process as applying for a birth certificate. Specify "genealogy copy only" on your application.
- **What documentation do I need to obtain a birth certificate?**
 - One primary form of identification is required to obtain a birth certificate. That primary identification can be a driver's license, state issued photo ID, military ID, valid passport, Department of Corrections ID issued within the past 6 months, school ID, work ID, veterans ID, or a green Mexico Consular ID. Proof of relationship or vested interest is also required if the applicant is not listed on the birth certificate.

- **What can I provide if I don't have any of the primary identification listed above?**
 - Two forms of secondary documentation would be required. See *link #6* for a list of acceptable documents.
- **How can I make an amendment/correction to my birth certificate?**
 - Since the process may vary depending on the type of correction needed, if other documents have been filed in the past, etc., it's best to contact the Vital Records staff at (812) 349-2542.

- **How do I find out if a child care facility/daycare is safe for my child?**
 - Inspection reports can be viewed for each facility (see *link #3*).
 - Indiana has successfully implemented a child care quality rating system, Paths to QUALITY™, which gives families an easy to recognize tool for selecting a child care program. Families can look for the Paths to QUALITY™ logo to determine what level their provider has achieved. Each level builds on the foundation of the previous one, resulting in significant quality improvements at each stage and in national accreditation at the highest level. The system validates child care programs for ongoing efforts to achieve higher standards of quality and provides incentives and awards for success (see *link #4*).
- **What do I do if I suspect child abuse or neglect by a child care staff or volunteer?**

- **What services are offered at the Futures Family Planning Clinic?**
 - Female exams including pap smears (cervical cancer screenings), pelvic, and breast exams
 - HPV testing if appropriate
 - Problem-focused genital examinations for males
 - Reproductive health counseling and education
 - Pregnancy counseling, testing, and referrals
 - Sexually transmitted infection (STI) testing and treatment, including HIV, gonorrhea and chlamydia testing
 - Vaginal infection testing and treatment

Complaints at the Monroe County Health Department (MCHD) are usually investigated within 24-48 business hours depending on risk. Although people can file anonymous complaints, food staff appreciate a name being left so the MCHD can properly follow up on the complaint. It's also advisable to bring the complaint to the attention of management at the food establishment since often times they can deal with the complaint in a more efficient and timely manner.
- **Grease Traps** – For Monroe County, contact City of Bloomington Utilities – (812) 349-3932
- **Illnesses** – If you suspect food poisoning, contact your physician and the local health department as soon as possible (see *link #3*). The physician will be able to conduct additional testing to help confirm the cause and support an investigation if launched.

FAQs:

- **Are animals allowed in food establishments?**
 - According to the ISDH Retail Food Establishment Sanitation Requirements, live animals may not be allowed in the operational areas of a retail food establishment. They may be allowed if the contamination of food, clean equipment, utensils, linens and unwrapped single-service and single-use articles cannot result, such as in the following situations:
 - Patrol dogs accompanying police or security officers
 - Service animals that are controlled by the disabled employee or person, if a health or safety hazard will not result from the presence or activities of the service animal
 - In areas that are not used for food preparation and are usually open for customers such as dining and sales areas
 - Pets in the common dining areas of institutional care facilities such as nursing homes and assisted living at times other than during meals if dining area, including tables and similar surfaces, are cleaned before the next meal serviceFood employees may not care for or handle animals that may be present such as patrol dogs, service animals or pets.
- **Where can I obtain food manager certification training?**
 - The State of Indiana requires most food establishments to have at least one Certified Food Manager available at all times, with documentation of certification on site and available for review. See [link #7](#) for Certification of Food Handler Requirements and for a list of classes in Monroe County. Please note, the ServSafe Food Handler Certificate does NOT meet Indiana State requirements for a Certified Food Safety Manager.
- **What restaurants should I eat at? / How can I get a copy of the most recent food inspection report for a particular food establishment?**
 - After a 10 day waiting period, inspection reports become public record and are available to view once you have filled out a Public Information Request (see [link #8](#)). There is a 10 cent a page charge for photocopying and most requests are filled within 48 hours.
- **Can I prepare food in my home to sell in a commercial operation?**
 - No. The Indiana State Food Code (see [link #9](#)) specifically states that food prepared in a private home cannot be offered for sale to the public. Options include building a separate kitchen that is not used as part of a private residence or using the kitchen of an approved licensed facility.
- **I bought food that's expired (out of date). Should I be concerned?**
 - Except for infant formula, product dating is not generally required by Federal regulations. However, if a calendar date is used, it must express both the month and day of the month (and the year, in the case of shelf and frozen products). If a calendar date is shown, immediately adjacent to the date must be a phrase explaining the meaning of that date such as "sell by" or "use before" (see [link #10](#)). Foods can develop an off odor, flavor or appearance due to spoilage bacteria. If a food has developed such characteristics, you should not use it for quality reasons.

- What should I do if I have maintenance problems in my rental unit?
 - Notify the landlord / agent of the problem. Keep a record of when you communicated with them. Give the owner a reasonable amount of time to take care of the problem. If the problem has not been corrected after taking these steps, contact HAND. An appointment will be scheduled for an inspector to come and investigate the reported violations. If violations are found, the owner will be issued a notice with an itemized list of repairs that must be made, and they will be given a deadline by which those repairs must be completed and re-inspected.

FAQs:

- **Who are most susceptible to lead poisoning?**
 - Young children are most vulnerable to the effects of lead poisoning due to their growing bodies absorbing lead at a faster rate than adults. Those living in homes built prior to 1978 are at the greatest risk, as many of these homes used lead-based paint and contain lead-contaminated dust. Paint chipping or deteriorating in these homes can pose a health hazard for its occupants and visitors.
- **How can I reduce my child's exposure to lead?**
 - Before you buy an older home, ask for a lead inspection, or visit your local home improvement store to buy a lead test kit.
 - Even if your child seems healthy, ask your doctor to test them for lead; lead poisoning often has no obvious or noticeable signs or symptoms.
 - Your local health department can provide you with helpful information about preventing childhood lead poisoning as well.
- **Where do I go to get myself, or my child, tested for lead poisoning?**
 - Contact your physician and ask them to test you, or your child for lead. Free testing is available around the state.

- **What should I do with expired or unwanted medications?**
 - There are four locations in Monroe County where you can drop off your unused, unwanted, or expired medicines:
 1. IU Health Bloomington Hospital Lobby at the Outpatient Pharmacy (601 W. 2nd St.)
 2. CVS Pharmacy (2701 E. 3rd St.)
 3. Monroe County Sheriff's Office (301 N. College Ave.)
 4. Monroe County Solid Waste Management District's Main Facility – Hazardous Waste Drop-off (3400 S. Walnut St.) (See *link #4*)
 - For outside of Monroe County, see *link #3*.
 - Controlled substances are often not included in community programs due to stricter regulations. Controlled substances are collected during the annual Drug Enforcement Administration (DEA) National Prescription Drug Take-Back Day. See *link #2* for updates.
- **What should I do if no collection programs are available in my area?**
 - It is advised to dissolve tablets and capsules in the original container with water. For liquid medicine, add flour or kitty litter to the bottle. Be sure to mark out any personal information and seal them in a bag to keep from leaking. The bag can then be thrown in the trash.
 - It is NOT advisable to flush medication down the toilet, run them down the sink or throw them in the trash without using the precautions above. Medication that is thrown in the trash may be ingested by children or animals and may also encourage the illegal use or theft of medicine. Medication washed down the drain is not removed by local wastewater treatment plants and ends up in rivers, streams, and lakes.

FAQs:

- **What is methamphetamine and how is it manufactured?**
 - Methamphetamine, or meth, is a highly toxic, powerful, addictive central nervous system stimulant that is illegally “cooked” in makeshift labs. It’s made with inexpensive over-the-counter ingredients such as pseudoephedrine (an ingredient in cold medications), acetone, anhydrous ammonia (fertilizer), ether, red phosphorous, and lithium.
- **What are the health effects of meth labs?**
 - It depends on the lab processes and the chemicals used, the amount of chemical and length of exposure, and the age and health of the person exposed. Exposure to meth residues may cause symptoms similar to those experienced by meth users. Other products released during the manufacture of meth can cause other symptoms and health problems. If you have concerns about your health or believe you have been exposed to meth residue or byproducts, contact your physician.
- **What is the process if an illegal drug lab is discovered?**
 - Law enforcement will dismantle, remove, and properly dispose of the lab and its contents. Addressing residual contamination from lab chemicals is the responsibility of the property owner and occupancy or selling of the property is prohibited until it has been properly decontaminated. A Qualified Inspector (see *link #3*) must be used for cleanup and to certify that the property has been properly cleaned.

 - First identify and correct the moisture problem, then clean up the mold. If you clean up the mold, but don't fix the water problem, more likely than not, the mold problem will come back.
- **Should I have my mold tested to find out what kind it is?**
 - Generally, it's not necessary to identify the species of mold growing in a building. If mold is seen or smelled, there is a potential health risk; therefore, no matter what type of mold is present, it should be removed.

- **What kind of diseases can mosquitos transmit?**
 - West Nile Virus, St. Louis Encephalitis, La Crosse Encephalitis and Eastern Equine Encephalitis are the ones that have been seen in Indiana.
- **What steps can I take to prevent mosquitos and mosquito bites?**
 - Mosquitos lay eggs in stagnant water, and will hatch 7 to 10 days later. Eliminating standing water on a weekly basis will prevent mosquitos from breeding.
 - If breeding sites cannot be eliminated, labeled pesticides may be used to prevent mosquito breeding.
 - The use of repellants containing DEET or Picaridin and minimizing outdoor activity during dusk and dawn when mosquitos are most active will prevent mosquito bites.

FAQs:

- **What are sharps and what should I do with used sharps?**
 - Sharps include needles, lancets and syringes.
 - Many communities have started collecting used sharps. Some of these programs are listed on the Indiana Department of Environmental Management's (IDEM) website (see link #5). Some pharmacies, doctor's offices and fire stations may accept used home-generated sharps. Some collection sites for household hazardous waste may also accept used sharps; these programs are often run by the local solid waste district or municipality.
- **What should I do if no collection programs are available in my area?**
 - If a collection site or event is not available, it is recommended to place used sharps in a rigid plastic container (bleach, detergent bottle, etc.). The bottle should then be sealed tightly and labeled "Do Not Recycle" for disposal in the household trash.
- **What should I do if I have accidentally been stuck by a needle?**
 - Wash the exposed area right away with water and soap or use a skin disinfectant (antiseptic) such as rubbing alcohol or hand sanitizer.
 - Seek immediate medical attention by calling your physician or local hospital.

FAQs:

- **Where is my septic system located?**
 - MCHD has records for many properties dating back to 1965 that include documentation of the septic system installation. The documentation does not always guarantee the septic system location, but it gives the inspectors an idea of where to look for the system.
- **How many bedrooms will my septic system handle and is my system large enough to add an additional bedroom?**
 - Septic systems are based on the number of bedrooms within the home, with each bedroom estimated to handle two people, or 150 gallons of water per room. An increase of bedrooms could possibly increase the amount of water usage placed on the septic system so the system would need to be adjusted to handle the increase.
- **Can I install a convenience bathroom in my garage and, if so, what do I need to do to my septic system?**
 - Adding a bathroom to the garage for convenience is not considered to be putting additional stress on the septic system, but it usually requires a septic repair permit from the local health department for the building department. This is more of an inspection of your existing septic system to ensure that the system is functioning correctly with no failing lines.

- **How can I test my home for radon?**
 - The MCHD assists area homeowners in their investigation of indoor radon gas levels throughout the County. Both short-term radon detectors and an electronic radon detector are used for those that request assistance.
- **What is radon?**
 - Radon is an invisible, odorless, tasteless, naturally occurring radioactive gas that comes from the natural breakdown of uranium. It can seep up through the ground and diffuse into the air. Radon is present in nearly all air, however, people who inhale high levels are at an increased risk of developing lung cancer. Basement and first floors typically have the highest radon levels because of their closeness to the ground.

FAQs:

- **What are a few basic requirements that pools and spas must meet to be open to the public?**
 - Weekly bacteriological samples must be submitted to the local health department.
 - Pools must be continuously and automatically disinfected and meet minimum residual levels for the type of pool and disinfectant (chlorine, bromine).
 - Daily logs recording disinfectant residuals and pH must be kept on site.
 - Pools are required to report injury / incidents to ISDH.
 - Reasons for closing a pool include cloudy water (unable to see main drain), missing drain cover, unsatisfactory bacteria samples, fecal accidents, or inadequate disinfectant, pH, or cyanuric acid levels.
- **What diseases can I get from swimming in a pool / spa that does not maintain water quality?**
 - Recreational Water Illnesses (RWIs) vary in type and severity. Gastrointestinal illnesses such as Cryptosporidium, Shigella, E. Coli and Norovirus occur in pools and spas each year. Respiratory infections such as Legionella and Pontiac Fever are common. Skin, ear and eye infections caused by Pseudomonas, Staph and Bacillus are also frequently associated with pools.

REGULATORY AGENCY: Tattoo parlors and body piercing facilities are not licensed or inspected by the Indiana State Department of Health (ISDH). However, all tattoo and body piercing facilities must comply with the State rule as established by ISDH (*see link #1*). The Monroe County Health Department (MCHD) can enforce this rule and, although there is no state certification for tattoo artists or body piercers, they are required to have annual training on Blood borne pathogens (universal precautions).

 - Typically the local health department. The MCHD can investigate tattoo parlors on a complaint only basis.
- **Can a minor receive tattooing or piercing without parental consent?**
 - NO. Tattooing or piercing a minor without parental consent is a criminal offense and should be referred to the local law enforcement (*see local resources*).
- **What should tattoo parlors and body piercing facilities do with their used needles?**
 - Facilities must comply with the State's Infectious Waste Rule when disposing of contaminated needles and other equipment (*see [IC 16-41-16](#)*).

- **What is considered an “abandoned vehicle”?**
 - A vehicle located on public property illegally.
 - A vehicle left on public property without being moved for twenty-four (24) hours.
 - A vehicle located on public property in such a manner as to constitute a hazard or obstruction to the movement of pedestrian or vehicular traffic on a public right-of-way.
 - A vehicle that has remained on private property without the consent of the owner or person in control of that property for more than forty-eight (48) hours.
 - A vehicle from which the engine, transmission, or differential has been removed or that is otherwise partially dismantled or inoperable and left on public property.
 - A vehicle that has been removed by a towing service or public agency upon request of an officer enforcing a statute or an ordinance other than this chapter if the impounded vehicle is not claimed or redeemed by the owner or the owner's agent within twenty (20) days after the vehicle's removal.
 - A vehicle that is at least three (3) model years old, is mechanically inoperable, and is left on private property continuously in a location visible from public property for more than twenty (20) days. For purposes of this subdivision, a vehicle covered by a tarpaulin or other plastic, vinyl, rubber, cloth, or textile covering is considered to be visible.

REGULATORY AGENCY: Although private water (well) systems are NOT REGULATED at the state or local levels, the Indiana State Department of Health (ISDH) does provide some testing at the state lab (see [link #1 for available tests at ISDH lab](#)). Well drillers are licensed by the Indiana Department of Natural Resources (DNR) Division of Water. Complaints regarding well drillers are investigated by DNR.

FAQs:

- **What should I do if my well sample tests unsafe (present) for bacteria (total coliform or e-coli)?**
 - Check the physical condition of the well to assure that the grouting is in good condition with adequate drainage, the wellhead is sealed, etc. If rain or surface water is entering the well from a crack in the well casing or other means, the well will become re-contaminated with bacteria. Then, the homeowner should be advised to disinfect the well (see [link #6](#)). Note that disinfecting the well will destroy any microorganisms, but will not impact any chemical contamination that may be present.
- **What should I do if my property was affected by flooding?**
 - If a property was affected by flooding and the wellhead was immersed in floodwaters, the well should be disinfected prior to testing.
- **What should I do if I've disinfected my well and my well sample still tests unsafe (present) for bacteria (total coliform or e-coli)?**
 - It is not unusual to have to disinfect the well several times in order to get a satisfactory ("absent") result.
 - If disinfecting does not work, the homeowner should contact a water treatment company or licensed well driller.

 - DNR maintains a Water Well Record Database (well logs) that can be accessed through [link #12](#).
