

ORDINANCE 2020 - 19

**An ordinance to amend the Personnel Policy Handbook of
Monroe County, the Tenth Judicial Circuit, and the Monroe County Prosecutor**

WHEREAS, the Personnel Policy Handbook (“Handbook”) of Monroe County, the Tenth Judicial Circuit, and the Monroe County Prosecutor was intended to be revised periodically to address the changing needs of and circumstances affecting these entities; and

WHEREAS, the Personnel Policy Committee has completed a review of the Handbook and has recommended revisions to several of its provisions; and

WHEREAS, representatives of the Board of Judges of the Tenth Judicial Circuit and the Monroe County Prosecutor have reviewed and approved the revisions to the Handbook proposed by the Personnel Committee; and

WHEREAS, the Monroe County Board of Commissioners (“Commissioners”) has reviewed the revisions to the Handbook proposed by the Personnel Committee and finds that these revisions should be approved.

NOW, THEREFORE, BE IT ORDAINED by the Commissioners, as follows:

1. The Personnel Policy Handbook of Monroe County, the Tenth Judicial Circuit, and the Monroe County Prosecutor shall be and is, hereby, amended. The Handbook is attached for reference hereto and marked as Exhibit A. Underlined language is to be added to the Handbook and strikethrough language is to be deleted from the Handbook.

2. This ordinance shall take effect upon adoption.
