REGULAR MEETING MINUTES

SURVEYOR REVIEW BOARD

Hybrid - Health Building Meeting Room and via Zoom App

June 21, 2022 at 4 PM

MEMBERS PRESENT: Todd Borgman, Eric Deckard (virtual), Rachel Oser

MEMBERS ABSENT: None

STAFF: Trohn Enright-Randolph (County Surveyor), Donna Barbrick (Secretary), Technical Services

I. Call to Order: Trohn Enright-Randolph called the meeting to order at 4:08.

II. Approval of Agenda

Motion to approve by Oser; second by Borgman. VOTE by roll call: 3-0 YES. Motion carried unanimously.

III. Approval of meeting minutes from April 19, 2022

Motion to approve by Borgman; second by Deckard. VOTE: 3-0 YES. Motion carried unanimously.

IV. New Business

a. Office Update

Trohn Enright-Randolph said we are continuing to move forward with filling the GIS Coordinator position and we are reaching out to private surveyors in the area for more perpetuation work and estimates.

b. Review of 0076 Deckard Land Surveying Corner Perpetuation Surveys

Trohn asked Eric Deckard if he wanted to say anything. Deckard said in some instances there will be corners that are called reference monuments. He said the theory of location would be found on the individual tie sheets. Trohn said there were about 25 section corners in this perpetuation survey and noted that many monuments on the survey were already held by MCSO. Rachel Oser noted a corner that Deckard set in the east quarter of Section 15 (Rich Q11). Trohn read the theory of location. Oser said it sounds straightforward.

Borgman had a question on Rich O13 and whether it agreed with what was held by Farkas. Deckard noted a Michael Bundy survey dated 1991 that held that fence post as well.

The surveyors had no questions on Section 11, Section 21 and Section 22. Trohn noted it was a well established area. He said we are getting a higher set of standards on these section corners. He said these surveys were done contiguously, we are getting geodetic controls and the survey will be recorded. Deckard noted looking at things four sections at a time brings a different perspective and the opportunity to look at any conflicting information and checking measurements.

Oser asked about the next perpetuation survey perhaps being connected to previous perpetuation surveys in Richland. Trohn said the focus has shifted a bit to county boundaries. He said I feel like it is in the interest of the county and the constituents to collect this data, so we have it if we need it. He said it is also a question of what is do-able. He said some work would be in very rural areas with limited records; there are a lot of factors. He said I do not intend to try to create an authoritative GIS layer; this would be for our

office. He said there could be better available data to help with taxing issues. He said after the county boundaries, the next goal will be township boundaries. He said I am open to suggestions.

Oser talked about her time working in MCSO and said we changed the GIS layer so that it is connected to the section lines so that you update the GIS with the proper coordinates. She said I think Trohn being able to update the layer every time he gets coordinates will help to fix the boundary a little better. There was a discussion of other counties and their methods.

Oser asked if a shape file was a deliverable on this survey. Trohn said no, we are not producing a survey product. He said there is room for improvement but many factors in how to correct the lines. Trohn said we are now in a position to update the layer and plan to do so. He talked about GIS vulnerabilities and how they have been improved. He said we have a strategic approach to doing this once we get a new GIS Coordinator. Trohn noted that this is a large discussion. He talked about Senate Bill 382 and attempts to fix overlaps and gaps with taxing parcels. He said the Department of Revenue wants to see this fixed. He said we need to know where our county boundaries are, so we are not in a situation where we have to work backwards to get it fixed. Trohn said he would like to get full sections along the county lines. He said he would like to see what it would cost to get four whole sections perpetuated, hopefully in the same township. He said the work would put us in a good position to protect property owners in the county.

Deckard said there may not be tied off monuments at township corners. He said when you get to a corner like this, it would be good to check around the surrounding area; we may have to investigate it by going into another section north or west of it (for example). Trohn talked about revising the service agreement template with a not-to-exceed amount, so that type of extra work could be accommodated. He said he did not anticipate any issues with the commissioners on that revision since it comes out of a dedicated fund.

V. Certification of corners: Van Bu U19, Rich S13

Van Buren U19. Trohn noted a 2006 tie sheet that called out a rebar with an Utt cap and a referenced survey from Guerrettaz. He talked about the new tiesheet referencing the same monument. Deckard had a question about witness A on the new tiesheet. Oser said she circled some typos on the draft tiesheet. Trohn said he would look at the field notes to check on the bearing and distance.

Deckard made a motion to table U19 and Richland S13 to a future meeting. Second by Borgman. Motion passed.





DETAIL OF MONUMENT SET AT THE NORTH 1/2 MILE OF THE ABOVE SECTION.










